• Area 3 is training this week – with a go live date of 4/7/14

- Area 4 kick off webinars are scheduled for 3/31/14 and 4/1/14
- Areas 1 + 2 are up and running with little or no major technological issues nothing that has stopped users from entering information

#### COMMUNITY DASHBOARD REVIEW - JIM BOMBACI - NUTMEG

- Reviewed the community dashboard excel sheet including areas of:
  - Data Completeness
  - NOFA Summary tables
  - Missing Data Rates
- Allows projects to see the UDE's that are not up to HUD compliance standards
- Reports are made available monthly to communities so they can improve their data quality

## Shelter Utilization Report Overview – Jeanne Miner – CCEH

- Jeanne Miner reviewed the new Shelter Utilization Report in ECM powerpoint is attached to these minutes
- Dana Dixon commented that the SUR has come a long way, but is still not perfect some information is not comprehensive such as the utilization rate, and some information isn't reporting correctly. Nutmeg and Empowered Solutions Group is actively working on the fix for this issue.

- There are just a handful of errors to correct in the system, which are mostly small in nature but it is just tracking down the programs to get their information in.
