A Message from Our CEO

Dear Friends,

If your days have been anything like mine over the last few weeks, they have left little room for contemplation. Whether involving back-to-back phone and zoom calls or providing direct care and services to others—not to mention putting out fires large and small, doing our best to learn the latest information about this wicked virus, all while helping to home school, and check in on loved ones—our days are packed to the brim.

I've now committed to spending at least 30 minutes each day to take a walk with my family, away from screens and phones, which has given me a little space to reflect. And one of the things I've reflected on is what it means to be a coalition at a time when we are told to socially distanced. At a time when it is more important than ever to join forces, we are forced to remain physically apart, our interactions mediated by technology, and with less chances for the type of unplanned conversations where ideas and opportunities so often truly arise.

Yet despite these challenges, I am amazed at what our coalition has done together these past few months. Through our shelter decompression effort, our coalition continues to execute the most assertive COVID-19 outbreak prevention effort for homeless populations in the country. Our coalition has quickly adapted to delivering services to people in shelters, providing meals via soup kitchens, and facilitating connections to housing while protecting staff and clients from the virus. Our coalition has received a massive amount of support from the private sector—assistance from realtors and landlords, furniture sets from IKEA, face masks from United Healthcare in partnership with CSH, charity workouts from local gyms, and countless grants and donations. And now our coalition is making plans to ramp up its efforts to divert and re-house as many as 1,000 households, and as systematic COVID-19 testing rolls out in shelters and hotels, to shift our COVID-19 infectious disease control approach from prevention to containment.

Our coalition is stronger than ever. And while we must continue to remain physical apart in the near term, I am excited at the chance to convene with all of you at our first ever virtual Annual Meeting taking place next Thursday, May 28th from 1-3pm, when we will come together to celebrate all that we've achieved together and to look ahead to all that we will accomplish in the future. We hope that you will all join us. Please note that members in good standing will have the opportunity to vote on our new board members and officers so do make sure you renew your membership if you haven't already done so before next week.

As always, the work of CCEH is only effective if we are meeting the needs of our members. Please continue to stay in touch with us and let us know how we can best support your efforts through this challenging time.
