A Letter From President Omar Kouatly

Dear Friends,

Last week we shared the news that CCEH's CEO, Richard Cho, is departing our organization for a senior position at the U.S. Department of Housing and Urban Development. Today is Richard's last day with CCEH, and I hope you will all join me in wishing him well.



While we are sad to lose Richard, it seems fitting that he is going on to play a key role in the Biden administration's efforts to combat homelessness. Under his leadership, CCEH has built on the legacies of Carol Walter and Lisa Tepper Bates, establishing Connecticut as a model for other states to emulate by demonstrating how a coordinated response can drive down homelessness by more than a third in a matter of years. The work that Richard has advanced has been remarkable, and has no doubt saved countless lives, especially during the course of the past year. We wish Richard well as he brings his talents to Washington. For my own part, I take comfort in knowing that we have somebody with such a keen understanding of the needs here in Connecticut driving our federal response to homelessness.

With change comes opportunity, and that is why I am thrilled to announce that the CCEH Board of Directors has enlisted the remarkable Evonne Klein to serve as Interim CEO. Many of you probably already are very familiar with Evonne and the pivotal role that she played as the first Commissioner of Housing for the State of CT in over 30 years. Affordable housing is a long running and deep passion of hers. During her tenure the Department had in some phase of construction 24,000 units of housing, of which 22,000 were/are affordable. She is recognized nationally as a leader in housing. In collaboration with CCEH under her administration CT was one of 3 states to effectively end veterans homelessness and significantly reduce the number of chronically homeless individuals as well as reduce the number of homeless families. Beyond her work as Housing Commissioner, Evonne has had a distinguished career fighting for justice, especially for the most vulnerable. As Co-Chair of the Fair Housing Working Group a number of pieces of zoning legislation were proposed such as state-wide inclusionary zoning, changes to the Zoning Enabling Act as well as the expansion of housing authority jurisdictions. She served as the First Selectwoman of Darien from 2003-2009. Some of her accomplishments include working with property and business owners to revitalize Downtown Darien; forming Darien's affordable housing advisory commission, adopting an affordable housing plan and spearheading the adoption and implementation of Darien's Inclusionary Zoning Regulation.

Evonne inherits an exceptional staff who together are committed to carrying

out the strategic plan directives outlined during Richard's tenure and to supporting our community in ensuring that we stay on track to meet our goal of making homelessness rare, brief, and non-recurring by the end of Governor Lamont's first term in office. I know that our staff and board are looking forward to working with the many voices that make up our coalition's networks to make good on this bold and audacious goal, and encourage you to reach out to make your voice heard and let us know how we can support you in your efforts.

As always, thanks to all of you for your commitment to CCEH's mission and work. We have shown that an end to homelessness is within reach, and look forward to working with you to get there.

Connecticut shelters have begun receiving the COVID-19 vaccine, as part of the Governor's plan to serve congregate settings through Phase 1b. Director of Technical Assistance and Capacity Building

This position leads and manages CCEH's team of professionals that provide technical assistance, training, and program performance improvement to providers within Connecticut's statewide homeless response system. The Director will lead CCEH's effort to improve and ensure the performance, responsiveness, and equitable impact of homeless services; supervise technical assistance and training team members; align efforts with state government, regional entities, homeless services providers, and Connecticut's two Continuums of Care; track and report on the team's deliverables and budget; and serve as part of CCEH's leadership and management team.

Policy Analyst / Senior Policy Analyst

This position is responsible for supporting the Director of Policy in policy analysis, agenda development, and execution of advocacy efforts to advance the mission of the Housing Equals Justice campaign. The Policy Analyst / Senior Policy Analyst examines federal, state and local policy for opportunities to expand the availability of affordable and supportive housing toward the goal of ensuring that homelessness is rare, brief, and non-recurring.
